### **Social Partner Specification**

Local Authorities have been tasked with the implementation of elements of the PEACE IV Programme. The PEACE Programme is a unique initiative aimed at reinforcing progress towards a peaceful and stable society in Northern Ireland and the Border Region of Ireland. PEACE IV will support actions that will develop and deepen reconciliation between divided communities; and increase tolerance and respect.

All Councils are required to produce a Local Peace & Reconciliation Action Plan which will be a targeted and locally based response to the needs that have been identified in the PEACE Programme. In order to oversee the development and implementation of the Plan a PEACE IV Partnership, that is representative of the community from across the Armagh City, Banbridge & Craigavon Borough Council area, will be established. This will be comprised of statutory representatives, the private sector, trade unions, elected members and the voluntary and community sector.

The Partnership will oversee delivery of the PEACE IV Action Plan under the following themes:

- Children & Young People Aged 0 -24: to enhance the capacity of children and young people to form positive and effective relationships with others of a different background and make a positive contribution to building a cohesive society.
- Shared Spaces and Services: to create a more cohesive society through an increased provision of shared spaces and services.
- Building Positive Relations at a Local Level: to promote relations characterised by respect, where cultural diversity is celebrated and people can live and socialise together, free from prejudice, hate and intolerance.

Armagh City, Banbridge & Craigavon Borough Council seeks to recruit social partners to serve on the PEACE IV Partnership. The Partnership would welcome applications from those with knowledge, skills and experience in peace building.

### **Pre-selection criteria**

- Must have completed the equal opportunities form.
- Must provide a referee who will provide information in relation to peace building work.

- Must be willing to act as an Individual Representative, in order to achieve the Outputs of the PEACE IV Programme, through the Local Action Plan for the good of all members of the community of the wider Borough.

#### **Essential Criteria**

- Be over 18 years of age
- Demonstrate sound local knowledge, skills and experience of the issues still remaining within the Council area in relation to sectarianism and racism and other barriers to peace building.
- Have a sound knowledge, experience and skills of 1 or more of the Thematic areas:
  - Children & Young People (Aged 0 24)
  - Shared Spaces & Services
  - Building Positive Relations
- Demonstrate experience of partnership working involving a range of partners such as community organisations, statutory agencies, local council etc.
- Be committed to pro-actively promoting and participating in all aspects of the PEACE IV Programme and encourage uptake from all sides of the community.
- Capacity to commit the time required to the work of the Partnership.

#### Desirable Criteria

- Demonstrate an understanding of the project appraisal process including assessing funding applications and tenders.

This is a voluntary appointment with only travel costs and minor expenses reimbursed.

#### Time Commitment

Will be approximately 2 hours for partnership monthly meetings with additional hours for participation in relevant sub-groups. It should be noted that during assessment periods this commitment may increase depending on the individual member's level of participation.
