The revisions to the policy will not have any impact on people in rural areas. The removal of the Rural Linkages Grant programme is mitigated by the fact that groups can apply to the Community Development Grant programme for the same projects and costs that were available under the Rural Linkages Grant programme. All revisions to the policy are communicated to potential applicants through information sessions delivered when calls for applications are opened, and through the relevant Applicant Guidance Manual.

<p>This original policy has been developed as a result of an extensive consultation exercise undertaken across the Armagh, Banbridge and Craigavon Council areas.</p> <p>To ensure maximum participation, consultation events were organised in each Council area with afternoon and evening sessions in each area. Two were held in Banbridge Town Hall, two in Armagh's Market Place Theatre and two in Craigavon Civic Centre. Through the three Councils, all community groups and other voluntary sector organisations on the Councils' Database were notified about the events. In addition adverts were placed in seven local newspapers. Those contacted were given the opportunity to contribute by a number of methods:</p> <ul style="list-style-type: none"> <li>• Through a link to an online questionnaire – this provided an opportunity to offer detailed information about current organisational needs and future priorities. The organisations that participated in this online questionnaire deal with issues which include disability, youth, early years, school children, older people, women, good relations, ethnic minorities and faith.</li> <li>• Through the six public consultation exercises - these were facilitated by Williamson Consulting and sought to focus specifically on views relating to the current Grant Aid programmes, future priorities and principles and any other information groups wished to contribute</li> <li>• By e-mail directly to Williamson Consulting</li> <li>• By telephone to Williamson Consulting</li> <li>• In addition, face to face meetings were held with network organisations in the area</li> </ul> <p>There was little disagreement about the key issues and groups consulted tended to provide similar responses, suggesting that the consultation is likely to be representative of the wider sector. Following subsequent amendments to the policy and procedures, workshops were held with potential applicants highlighting the changes and a section was included in the Applicant Guidance Manuals detailing the changes.</p>

A common theme that arose through the community consultation was that of rural isolation and the difficulty of connecting people with provision. This usually centred on transport needs, particularly for young people and older people. The policy initially sought to address this need by introducing the Rural Linkages Grant programme. However, due to lack of uptake and the ability of applicants to apply for the same costs through the Community Development grant programme, the Rural Linkages Grant was closed. Groups were made aware of this change and the ability to apply to the Community Development Grant programme through a series of information sessions and details of changes highlighted in the relevant Applicant Guidance Manuals.

The social needs of people in rural areas in particular has been considered in devising the policy. The borough has significant areas classified as rural and so the policy seeks to support community and voluntary sector organisations to address some of the particular issues experienced by rural communities, for example:

- Rural isolation
- Lack of access to services
- Social exclusion

These barriers manifest themselves in lack of transport, poor or non-existent community facilities, little or no services to meet community needs.

The rural needs identified have underpinned the need to continue to ensure that access to financial assistance for groups serving rural areas and meeting rural needs is not adversely affected by any revisions.

As a result, while the Rural Linkages Grant is no longer available, groups who would or could have applied to it can still apply for the same projects and costs through the Community Development Grant programme.

Specific grant programme objectives which may have particular relevance for groups operating in rural areas or seeking to meet rural needs have been retained, including:

- Increased social inclusion (tackling marginalization)
- Reduced social isolation
- Better services for those in need
- Improved community cohesion
- Improve facilities, access or services

In respect of eligibility to apply for annual core running costs, rural development associations are specifically named as an eligible group. Similarly, projects that are eligible for funding for capital funding specifically include "capital expenditure to facilitate the provision of mobile services in rural areas".
