The Banbridge Town Dressing Project is part of the Banbridge Benefits Realisation Project which was aimed at supporting the town as it entered into a new era in its development and particularly given the opening of the multi-million fund Game of Thrones Studio Tour.

The dressing project aims to install 40 no. 6m and 8m Flagpoles. It is believed once installed the flag poles will greatly enhance the gateways and approaches to the town centre, and will allow the council to showcase Banbridge at particular periods in the year through banners. The locations have been specifically selected because of their prominence. As a result of the planning permission process 2 sites were removed from the scheme.

Intended aims/outcomes. What is the policy trying to achieve?

As part of its ongoing commitment to urban regeneration, Armagh City, Banbridge and Craigavon Borough Council proposes to install 40 No. 6m and 8m Flagpoles which will enhance the gateways and approaches to the town to highlight particular periods in the year through banners.

Planning Permission – approvals gained however during the planning permission process a number of planning objections were made on the grounds of issue with noise and traffic disruption.

These concerns were taken on board and 2 sites were removed from the planning process.

To address the concerns raised banners will be secured top and bottom in order to ensure any noise is kept to a minimum and DfI will be consulted as to the impact on traffic and their guidance has been used to inform the project on how to proceed.

While we don't anticipate difficulties, there may be a possibility that other flags could be attached to the flagpoles within the residential areas and as a result this may have a negative impact on equality and good relations within these areas.

However, while we don't anticipate difficulties, there may be a possibility that other flags could be attached to the flagpoles within the residential areas and as a result this may have a negative impact on equality and good relations within these areas.

2. Similar flag poles have been erected in Armagh City but to date there have not been any issues.
