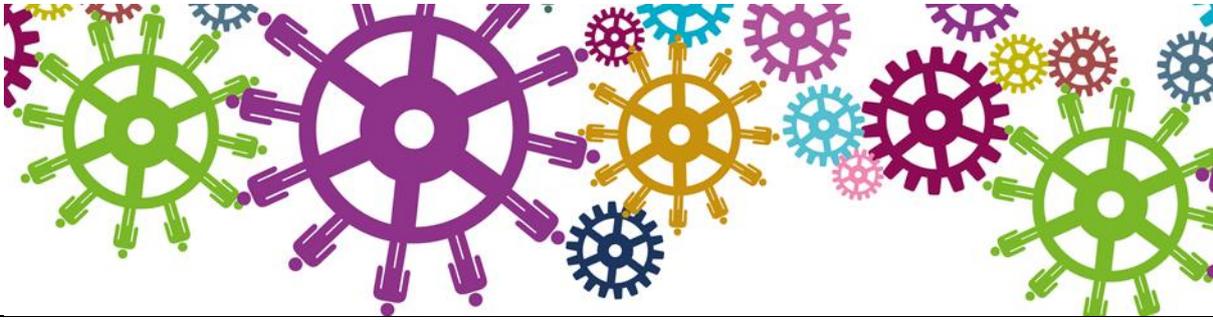

## **1. Welcome and Introductions**

John McGuinness, ABC Community Network welcomed members as Chair of the Community and Voluntary Sector Panel meeting. Introductions were made and a number of apologies had been received and would be recorded in the meeting notes.

John advised that the meeting would be facilitated by Anna Clarke, Prospects Award and welcomed Anna to the meeting.

## **2. Notes of previous meeting 20<sup>th</sup> August 2018**

John went through the matters arising from the notes of the Community and Voluntary Sector Panel (CVSP) meeting on 20 August 2018 that were previously circulated:

- Volunteer Expenses  
Community planning team undertook some research around expenses and a recommendation was going to the Council and the Community Planning Strategic

Partnership for mileage to be payable to panel members who weren't able to claim costs through own group.

- **Panel Support Plan**

John explained that progress on this had commenced, he advised that himself, Geraldine Lawless and Sheila McCreesh the Community Planning Team and Anna attended a meeting with the Manager of Peace IV to discuss the option of developmental programme for panel members to be supported through the Peace IV programme. He advised Anna would cover this under agenda item 4.

- **Membership of panel**

John reminded members, there had been some discussions at the previous meeting and the

John invited Jennie Dunlop, Community and Strategic Planning Manager to give a brief update on Community Planning progress since the last meeting on 20<sup>th</sup> August.

**Action Plans:**

*Economy theme:* Skilled and Enterprising Economy TAP team presented their first progress report to the CPSP in September. Tourism Economy were due to present their first progress report to the next

*Community theme:* The chairs of Confident and Welcoming Community TAP team and the Healthy Community TAP team presented the action plans to the CPSP in September, work is ongoing with action coordinators of each team to set performance measures.

*Place theme:* Action planning workshops for Creative Place are underway with the final session scheduled for 22<sup>nd</sup> November. Enhanced and Revitalised Place will commence in January 2019.

### 3. **Chairs Update**

By way of update, John advised that panel that himself and Brendan McCann attended the Community Planning Strategic Partnership meeting 13<sup>th</sup> September. John advised that the Code of Conduct and the Terms of Reference for the Panel was approved by the CPSP. He added that himself and Brendan covered all points raised at the previous Panel meeting in August. Sheila McCreesh advised that she had attended the CPSP away day on the 26<sup>th</sup> September.

### 4. **Build the Buzz**

Anna explained, this part of the meeting was an opportunity to identify themes that the Panel could use as a conduit to engage and connect with communities. She remarked that Panel members are and hold the key links into communities.

Anna explained that herself and the community planning team along with John, Geraldine and Sheila had met with John Devaney, the Manager of Peace IV to discuss the option of developmental programme for panel members to be supported through the Peace IV programme. Anna shared with panel members the draft proposal that was sent to Peace IV, and that through this session there would be an opportunity for panel members to shape and design the final proposal that would be submitted to Peace IV.

Each table conducted an exercise to identify themes/issues that are concerning and impacting people in the borough. The groups identified emerging themes and prioritised the top 3 for their table thinking about three questions: *1. Why these themes are important?* *2. How do they affect people?*, *3. Why do they matter?*

During discussions Appendix 1, the panel members agreed the Top 3 areas where:

1. Mental Health and Well-being
2. Education, Training, Employment and Economy
3. Communities/CVS
