Update for Indoor Leisure staff from the Leisure Transformation Project Team

1. <u>New Job Descriptions for indoor leisure sites (excluding South Lake Leisure</u> <u>Centre)</u>

All roles are currently being drafted and will be with staff for informal consultation as soon as possible.

These job descriptions will be available to view on the Leisure Matters page; staff feedback will be essential and important before we move to the formal evaluation process.

2. Proposed process for filling posts in SLLC

- Collective Consultation on SLLC letter posted out to affected employees Friday 3rd April 2020.
- Offers of suitable alternative employment out by 17th April 2020.
- Employee requests for consideration for Voluntary Redundancy to be made by 1st May 2020 (dependent on availability of Voluntary Redundancy and NILGOSC calculations).
- Acceptance of suitable alternative employment offers by 1st May 2020.

 1-1 formal consultation with employees requesting Voluntary Redundancy during 1st week in May 2020 (dependent on availability of Voluntary Redundancy and NILGOSC calculations).



- Decision on employee requests for Voluntary Redundancy by mid-May 2020.
- Internal recruitment to fill vacant roles is dependent on current Coronavirus situation. TBC
- Leaving dates for employees accepted for Voluntary Redundancy is dependent on current Coronavirus situation: TBC
- Starting dates for new roles in SLLC is pending on current Coronavirus situation: TBC

3. Staff Survey

A new staff survey has been completed and will be distributed to all indoor leisure staff once the Covid-19 situation has been resolved and we return to normal duties.



4. South Lake Leisure Centre Build

Farrans suspend work at South Lake Leisure Centre from Friday 27th March 2020

In light of the continuing and escalating COVID-19 pandemic Farrans have been continually reviewing and amending their risk management strategies in line with government guidance, advice and CDM Requirements relating to: managing ill staff, travelling to and from the site, hygiene and welfare requirements, and social distancing.

Upon review, Farrans made the decision to suspend all work on site in line with The Public Health Notifiable Diseases Order (Northern Ireland) 2020. This will be a planned shutdown over a number of days due to the advanced nature of construction and the complexity of systems that are currently live.

Please be assured that South Lake Leisure Centre (SLLC) remains a priority for the Council and the project team, and Officers are working with Farrans and others to secure clarity around a start-up programme and that will be discussed with Members in due course.

The Operational project team remains focussed on opening on 15th August, and is now meeting, virtually, three times a week to maintain as much momentum as possible. Due to the nature of this evolving situation, this may not be possible depending on how things progress, but Officers will continue to work on the programme to be prepared to accept handover of the building when ready.

Wherever possible Officers will strive towards shortening the period it will take to migrate to and mobilise SLLC, with that proviso that the building can only be opened once it is safe to do so. Officers will continue to keep staff informed and involved in the delivery programme as far as it is practicable.

As the site remains in Farrans possession during the closure, the contractor is responsible for enhancing security and the site will be regularly monitored by Farrans personnel.

Council is very aware that when the site construction restarts this will be a very positive message to the citizens of the Borough and Officers will continue to work

on ways to engage with existing and potential customers during this period, particularly where existing centres are closed.
