## **On-line Training**

Covid-19 Lifeguard Competency Assessment Training continues with Staff in preparation for the reopening of the swimming pools; further dates will be confirmed.

This training will continue over the next few weeks so to ensure high standards are maintained.

## **SLLC on-site training**

Work is now underway to pull together a 3 week training plan for the onsite site specific training in September 2020.

This will include training in the following areas for staff;

## Update from the 'Leisure Transformation Project Team'

The 'Leisure Transformation Project Team' would like to give information regarding some of the projects that we have been working during the closure on a number of projects in relation to indoor leisure across the Borough;


#### Re-opening of swimming in our indoor leisure facilities

As you are aware we reopened a number of swimming pools in the Armagh, Banbridge and Craigavon Borough Area on Thursday 7<sup>th</sup> August 2020, with restricted times for public swimming.

• Cascades Leisure Complex initially was to open for public swimming only on Saturday's; however, days have been added due to demand.







## **Cascades Leisure Complex**

The swimming has proved a popular with our customers (public and Clubs), it was lovely to see them back in the facilities again.

#### Extended swim programme

During this initial opening phase members so the public over the age of 16 were allowed to swim on an individual basis, lane swimming only; however, this is now being extend the swim programme on offer to the customer.

Obviously due to the Covid-19 there will be a number of restrictions, which include:

## • Family group;

Family/Household groups will be able to hire a lane or a section of a small pool from 24<sup>th</sup> August 2020 .....they belong to a "social bubble" - they do not have to social distance in the water, but they all must stay in their allocated area.



There will be:

- > 2 X Family Swim Sections available in each facility.
- > Max 6 people per section  $-2 \times Booms$  segregating the two families.
- > Our Normal Child to Adult Ratio Policy Applies:
  - 1 Adult to 2 Children under 4yrs
  - 1 Adult to 3 Children between 4-7yrs

Effectively 3 adults could come with 3 children or 4 with two children but not our concern if they are in a family bubble

- Booking in advance by one member of the family.
- Restrictions to changing facilities; however, showering after swims will be facilitated from 24<sup>th</sup> August 2020. (Showers will be cleaned by staff between swim sessions). (We will continue to ask all swimmers to shower at home before swimming we are not opening pre-cleanse showing until further notice).
- Staff on poolside just need to make sure that the policy is being adhered to.
- The charge for the family swim will be £8.70 regardless of 2 or 6 people.



### • Lane swimming for under 16

Lane swimmers from 8 years of age to 15 years of age will be facilitated from 24<sup>th</sup> August 2020.

- i. These will be separate "under 16" sessions in each centre's programme.
- ii. The 8-15 year old can be accompanied (in the lane swimming) by one responsible adult only, also lane swimming and social distancing.
- iii. Parents or adults who bring 8-15 year old to centre, and who are not the one accompanying adult in the water, cannot wait in the centre - (except the open café area at OLC) - they should wait outside the centre as we are not opening up spectator areas or seating areas).

### • Aqua-Aerobics

Sessions such as aqua aerobics (16 and over) will be facilitated (subject to instructor's availability at each centre) from 24<sup>th</sup> August 2020.
